EDH CSD BOARD OF DIRECTORS APPROVES EXPANDED SCOPE OF WORK FOR BASS LAKE REGIONAL PARK ENVIRONMENTAL REVIEW

TRANSPORTATION IMPACT STUDY TO CONSIDER BASS LAKE ROAD ROUNDABOUT AT BRIDLEWOOD DRIVE

The September 9, 2021 El Dorado Hills Community Services District (EDH CSD) Board of Directors meeting included an agenda item to increase the scope of work for the Bass Lake Regional Park environmental review / Traffic Impact Study currently underway.

From the EDH CSD Agenda:

Bass Lake Regional Park – Additional Augment to LSA Scope of Work for Expanded Traffic Impact Study (TIS) Analysis

Recommended Action: Approve an additional augment to LSA's Scope of Work to allow for the expand Traffic Impact Study ("TIS") analysis for the Bass Lake Regional Park ("Park")

CEQA process.

Background: The El Dorado Hills Community Services District ("District") contracted with LSA in November 2019 to provide engineering and environmental studies and reports related to the CEQA process for the Bass Lake Regional Park project. Since approval of the initial contract, a series of design changes have occurred, and critical feedback has been received by El Dorado County ("County") after review of the submitted Pre-Application and Traffic Impact Study. Most recently, the discussion of adding a roundabout at Bridlewood and Bass Lake Road has brought forward additional intersection evaluations required by the *County, which were not originally part of* LSA's Scope of Work, nor a part of the June 2021 augment. Discussion: LSA has prepared an additional augment proposal to the original contract scope -(continued on page 2)

MANDATORY 11-DIGIT DIALING FOR 530 AREA CODE

Mandatory 11-digit dialing will become effective October 24, 2021, within our 530 area code and for some other California and other states area codes. The new 11-digit local dialing must be implemented in order for a new National Suicide Prevention and Mental Health Crisis Lifeline 988 number to work in our area which will be effective on July 16, 2022.

This does mean that all automatic dialing equipment or other types of equipment that are programmed to complete calls to seven digit local numbers will need to be reprogrammed to complete calls. This would include life safety systems for medical monitoring devices, PBX's, fax machines, internet dial-up numbers, fire or burglar alarm and security systems or gates, speed dialers, mobile or other wireless phone contact lists, call forwarding settings, and other similar functions. It is suggested that you check your pet IDs, business checks, advertising materials or business stationery to verify the area code is included.

Other affected California area codes include: 209, 562, 626, 650, 707, 925, 949, and 951.

According to the information that was received virtually everything else remains the same.

Environmental/Project Planning Consultant LSA August 20, 2021 Letter to EDH CSD

LSA is currently under contract to prepare a Transportation Impact Study (TIS) for the El Dorado Hills Bass Lake Regional Park Project (Project). Currently, the TIS proposes to analyze the intersection of Bass Lake Road/ Project Driveway 3 – Bridlewood Drive as a stop-controlled intersection. As per information provided by the Community Services District (CSD), this intersection may be converted into a roundabout under with project conditions contingent upon funding availability. As such, for purposes of this analysis, an additional analysis will be conducted considering this intersection as a roundabout under all analysis scenarios. Recently, County staff also requested five additional intersections to be included in the TIS. Therefore, LSA is submitting this contract amendment request for inclusion of these additional tasks in the TIS. Following is a list of the tasks: • Task 1: Intersection Level of Service (LOS) Analysis – LSA will perform an intersection level of service analysis on a typical weekday (during a.m. and p.m. peak hours) and on a typical Saturday (during midday peak hour only) for both access alternatives and across all analysis scenarios for these five additional intersections that were not included in the previous scope of work. For purposes of this analysis, new weekday and Saturday counts need to be collected at all study intersections. Cost: \$16,500 • Task 2: Intersection Queuing Analysis – LSA will perform a queuing analysis at all new study intersections on both a typical weekday and a typical Saturday. Cost: \$3,500 • Task 3: Roundabout Analysis – LSA will perform a roundabout analysis at the intersection of

Bass Lake Road/Project Driveway 3 – Bridlewood Drive under Access Alternative 2 for all analysis scenarios. The analysis will be performed using Sidra. Cost: \$9,000 • Task 4: Project Management – LSA will continue to perform project management activities including but not limited to coordination with the CSD and the project team, review of project schedule and budget, and preparation of invoicing and other documentation at the request of the CSD. Cost: \$2,000

The history of the proposed Bridlewood Drive Roundabout dates back to August 2019, when the Serrano Village J7 project was being considered before the Planning Commission to decrease density from the previously approved project with 72 housing units, down to 65 housing units. The Bass Lake Action Committee's Traffic Safety Committee submitted a public comment concerned about the lack of Bass Lake Road improvements, many of which had been removed from the County's Capital Improvement Plan (CIP) in 2015/16. The Bass Lake Road frontage improvements required for the Serrano Village J7 project were not to be constructed with the project, just funded for construction at an unidentified future date (when the 2019 dollars would be inadequate to actually fully fund the improvements).

The TSC had asked about mitigation at the Serrano J7 entrance intersection being only 400 feet away from the Bridlewood Drive intersection on Bass Lake Road, located on a curve with poor sightlines at the Bass Lake Overflow. The TSC had suggested eliminating all left turn movements at the Serrano J7 intersection, along with a left turn pocket for Bridlewood Drive. Lacking the funding for a left turn pocket at Bridlewood Drive, the TSC asked about a potential roundabout, since the state provides grant funding for roundabout projects.

The TSC had collected ten years of accident data for Bass Lake Road that indicated more rear-end accidents occurred on Bass Lake Road at Bridlewood Drive, than on Green Valley Road at Bass Lake Road. The TSC felt that the Bridlewood Drive intersection required improvement. El Dorado County Transportation Department responded that traffic volume and conditions at the intersection required no improvement. The Planning Commission sought an updated traffic study of the intersection that determined that that a left turn pocket was warranted under existing conditions – before the Serrano J7 project would be built.

- Your telephone number, including current area code, will not change.
- The price of a call, coverage area, or other rates and services will not change due to the dialing change.
- What is a local call now will remain a local call regardless of the number of digits dialed.
- You will continue to dial 1+ area code + telephone number for all long distance calls.
- You can still dial just three digits to reach 711 (relay services) and 911 (emergency services).
- Any 211, 311, 411, 511, 611, or 811 services available in your community can still be reached by dialing their three-digit codes.

As an aside, interestingly, while many of us have switched completely to cell or digital phones, almost 40% of adults still have a landline, according to Felix Richter in his March 17, 2021 article, Landlines Phones are a Dying Breed.

Landlines can be necessary for some medical devices or security systems as well as faxes. Since traditional phones are self powering, they will probably work when the power is out. However, in our experience they did not work during our past planned PG&E power outages in this area because of a problem at the switching station. A landline can be the best if you want 911 access tied to your location.

However, since the traffic study indicated that the conditions "barely" qualified for a left turn pocket, and because it was an existing need, offsite (by 400 feet) of the J7 project, and that the J7 project only generated an additional 13 daily trips at the intersection, the County could not make a left turn pocket at Bridlewood Drive a condition of project approval. With no development funding, and no funding identified in the CIP, the Bridlewood Drive left turn pocket would have to be added to the un-Funded CIP list. Projects on the CIP generally fall into the 10 to 20 year timeline, meaning that projects on the un-Funded list are effectively projects that will never happen.

The Serrano J7 project was approved by the Planning Commission. But County Auditor Controller Joe Harn filed an appeal of the project before the Board of Supervisors citing the lack of progress on the remaining 12.5 acre parkland dedication of the 30 year old Serrano Project, now identified at Bass Lake – Village J Lot H, along with inadequate traffic conditions on Bass Lake Road.

In January 2020, El Dorado County Transportation Department Staff invited Bass Lake Action Committee TSC members to a discussion about Bridlewood Drive. Staff shared information that two proposed left tun pockets and a refuge lane on Bass Lake Road at Bridlewood Drive, and at the Serrano J7 entrance could cost just under \$4 million, and had no identified funding. Staff then proposed that a roundabout at the Bridlewood Drive intersection could be priced at under \$3 million, and could qualify for grant funding - but only if there were seed money. The concept was that Serrano Associates would provide an amount, which later was revealed to be \$200,000, and that Bridlewood Canyon property owners would assess themselves via a CFD/levy to provide additional seed funding that would qualify a conceptual roundabout for grant funding.

TSC members indicated that was something worth exploring, but it would be up to Bridlewood Canyon owners to determine if they were interested. At the meeting TSC members asked if the County had approached the EDH CSD regarding the roundabout, as the EDH CSD was looking for pedestrian access points into the proposed Bass Lake Regional Park. The County had not spoken to the EDH CSD. Improvements to Bass Lake Road and pedestrian connectivity and safety for any proposed park facility at Bass Lake have been the primary concern of the Bass Lake Action Committee since 2003.

At the Board of Supervisors Appeal hearing in January 2020, a compromise was suggested that the County would resolve the Bridlewood Drive

left turn concern with a roundabout, with Serrano Associates providing \$200,000, and that Bridlewood Canyon owners would be asked to approve a levy on their properties via assessment to provide additional grant qualifying funding. If the Bridlewood Canyon owners did not agree to an assessment, then the \$200,000 would be returned to Serrano Associates. The Board of Supervisors added this to the Serrano J7 Conditions of Approval, and denied the appeal. Bridlewood Canyon owners, or the Bridlewood Canyon HOA were consulted.

At the EDH CSD Board meeting, directors observed that they were compelled to "go along" with the roundabout request, because the District 1 Supervisor wanted the project, and that the EDH CSD was being impacted "disproportionately."

(Time stamp 3Hrs 49Mins) The EDH CSD Board did approve the additional scope of work for LSA, and the \$31,000 in additional costs.

However, the roundabout project is not simply a project that the District 1 Supervisor desires residents desire solutions to our ongoing traffic safety concerns on Bass Lake Road. The proposed roundabout has been the only solution for area traffic concerns that the Transportation Department has suggested to residents that is obtainable. For over twenty years, Bass Lake Area residents have clamored for improvements to Bass Lake Road. And while the funding solution the Transportation Department has proposed seems to be centered on the belief that the Bridlewood Drive intersection is an issue for only Bridlewood Canyon residents, and that they should be responsible for partially funding it, the truth is that the intersection is an issue for the entire Bass Lake Community, and for motorists that use Bass Lake Road. Bridlewood Canyon was developed beginning in the 1980s, and the development paid traffic impact fees. Bridlewood Canyon residents aren't the cause of the intersection problems, it was primarily all of the subsequent development approved in the 1990s and 2000s.

The Transportation Impact Analysis for the BLRP being conducted by LSA had considered a stop sign controlled intersection at Bridlewood Drive and Bass Lake Road, with a driveway onto the Park property. In the past, the Transportation Department has informed the Bass Lake Action Committee that a stop sign controlled intersection on a two lane Bass Lake Road at Bridlewood Drive would be "unworkable". A roundabout may be the project that provides an acceptable solution.

The Bass Lake Regional Park, which the Bass Lake Action Committee fully supports, is proposed to bring at least 700 parking spaces, and may reach closer to 1000 spaces – almost as many potential vehicles as the existing Bridlewood Canyon and Woodridge developments combined. The Park project as proposed will be bringing significant, While the EDH CSD isn't an agency that normally has to focus on traffic impacts for typical neighborhood or village parks, the BLRP Project is so much more massive in scope that the traffic impacts cannot be ignored, and must be mitigated. The Bass Lake Action Committee is committed to seeing a solution that addresses the current inadequacies of Bass Lake Road, the Park project traffic impacts, and provides safe pedestrian access to the Park property for residents near the lake. ~

TRANSITIONING HOUSING MARKET?

"The California housing market continues to normalize from the white-hot condition we experienced during the pandemic with both sales and prices moderating...." according to CAR President Dave Walsh.

In his recent article, El Dorado County realtor Ken Calhoun related that June was the peak of the market with the median home in El Dorado County selling at \$673,000. The median price was \$625,000 by July and the number of sales fell by 11%. The August home sales were less than July, however, the median sales price was approximately \$650,000.

With El Dorado Hills being the preferred rural destination for Bay Area buyers moving to El Dorado County, the increased demand and rising prices has raised the median sales price for the county. The median selling price for El Dorado County has been averaging about \$625,000 which is a 19% increase over last year. El Dorado Hills median selling price year-to-date is \$890,000, a 23% increase over last year.

The million-dollar home sales in El Dorado Hills have been increasing the County's average selling prices. In 2020, million-dollar homes accounted for 7% of the home sales for the county. This year they have accounted for 16% of all home sales and 75% of the homes were in El Dorado Hills.

There has been a 75% increase in listings from last spring, however, 65% of all current county listings are in excess of \$600,000. There are more homes listed at \$1,000,000 or more then less than \$475,000.

Calhoun believes that new listings will gradually increase over the fall and winter with a surge in the spring when more California homeowners continue to move out of the state. With the equity that owners have in their homes, there will be plenty of opportunities next spring.

- mark the beginning of a new astronomical season every year. They have played an important role in ancient culture for millennia with many myths and traditions. Traditionally celebrations of the autumnal equinox are associated with harvest, the turning colors of the leaves and ripening of the crops.

While the Romans held a festival which was dedicated to Pomona who was a goddess of fruit and growing things, the most famous ancient myth comes from Greece.

The beginning of fall is closely linked to the story of the abduction of the goddess Persephone, also called Kore or Cora, in major Greek mythology. She was abducted from her mother, the harvest goddess Demeter, and taken to the underworld to become the wife of the god-king, Hades.

Demeter eventually was able to get her daughter back from Hades but only for 9 months of the year. Persephone would return to the underworld to spend 3 months with Hades every fall. Demeter would not use her divine skills to make plants grow for those months and this explains why we have 3 months of winter every year.

The Harvest Moon, which is also called the Corn Moon or Full Corn Moon, is closest to the September equinox. It is astronomically special because the time between one moonrise to the next becomes shorter around this period. This year we will have a Harvest Moon on September 20th at 4:54 p.m.

Daylight Savings Time will end on Sunday, November 7, at 2AM.

Higher Propane Prices <u>This</u> Winter?

Higher crude oil prices, seasonal withdrawals from propane inventory, and increased global demand for U.S. propane exports lead to increased propane prices to the consumer during the 2020-2021winter and it appears we can expect the same in the coming 2021-2022 winter too.

Propane is primarily a byproduct of oil and gas production and a smaller volume is a byproduct of oil refining. The production of propane increased as the Shale Revolution (hydraulic fracturing and horizontal drilling which now account for 36% of the - (Continued on page 6)

GROCERY OUTLET MARKET PROPOSED FOR CAMERON PARK SHOPPING CENTER

A proposed Grocery Outlet store on Green Valley Road between Cambridge Road and Winterhaven Drive has a Public Hearing scheduled for September 27 2021 to review a proposed mitigated negative declaration.

From the Notice of Intent to Adopt a Mitigated Negative Declaration:

The County of El Dorado, as lead agency, has prepared a Mitigated Negative Declaration (MND) for the below referenced Project. The Draft MND analyzes the potential environmental effects associated with the proposed Project in accordance with the California Environmental Quality Act (CEQA).

This Notice of Intent (NOI) is to provide responsible agencies and other interested parties with notice of the availability of the Draft MND and solicit comments and concerns regarding the environmental issues associated with the proposed Project.

A Planned Development Revision, PD-R20-0009, to modify an approved development plan, PD05-0004 Green Valley Station, to allow development of a new 16,061 square foot market, Grocery Outlet, on a 2.0acre portion of the 5.37-acre parcel. In accordance with the Parking and Loading Standards in the Community Design Standards, the project includes associated improvements for 77 standard parking spaces, four (4) handicapped-accessible parking spaces, lighting, landscaping, recycling/trash enclosures, building signage, and one freestanding monument sign.

Access would be from Green Valley Road, a County-maintained roadway. The project includes road improvements to Green Valley Road, with a 6-ft wide meandering sidewalk along part of the northern property boundary line adjacent to Green Valley Road, and expansion of the existing utilities on-site by extending the public utility lines with 400-ft of sewer force main and 1,400-ft of waterline. Electricity/utilities would be provided by connecting to PG&E. Typical hours of operation are 8:00am-9:00pm 7 days per week, and the number of employees would be 30. There would be mutual access and reciprocal shared parking between both developments for Phase I and a portion of Phase II for the Green Valley Station.

A feature that is noted in the Application Packet on page 25 <u>http://basslakeaction.net/</u> <u>grocery-outlet-app</u> is that later phase / future development on the site shows the potential for two Quick Service Restaurants (QSR) each with a drive thru lane.

beginning and volumes doubled between 2011 and 2019. During this time the consumer demand in the United States (U.S.) for propane was flat, but exports increased to balance the market.

Previously, propane prices had been lower because capacity at the docks was not sufficient to export the entire surplus of shale driven propane production growth.

The production of propane tended to stay ahead of the demand internationally and the export dock capacity, resulting in a market surplus much of the time. Eventually, the market did respond and international buyers, especially in Asia, began expanding plants using the imported propane and stock capacity was increased to allow for more exports.

More recently the U.S. has been competing with the exports which have accounted for about 60% of the demand of U.S. production.

When Covid-19 reached the U.S., propane production fell as well as crude, natural gas and NGLs (Natural Gas Liquids). The supply-demand imbalance was thrown into limbo and inventories were at record highs with export volumes dropping but not for very long. They quickly returned to the pre Covid-19 levels and did not seem to be affected by the disruptions that affected other energy markets during 2020.

Prices needed to increase in order to increase U.S. inventories and discourage the exportation of propane. However, as of July 2021, the export of propane was still very high and production was only slightly increased. This resulted in an insufficient replenishment of stock for the market to be comfortable with the winter season needs.

As many of you may have noticed our propane prices did not fall this summer which would normally happen. Propane futures on June 30, 2021, were trading at \$1.09 and \$.95 cents a gallon respectively at the hubs in Mont Belvieu, Texas and Conway, Kansas. This is roughly twice their levels for the past two summers and spot prices moved in a similar way.

Retail prices rose but not sharply and the Energy Information Administration (EIA) indicated that U.S. households could expect to spend an average of 14% more on propane this coming winter, and perhaps even more if the forecasted weather is colder than expected.

Early Deadline on the Communities of **Interest Redistricting Component**

The El Dorado County Geographic Information System (GIS) Department was able to begin to create map alternatives for redistricting six weeks earlier than planned because of the early release of the data needed from the U.S. Census Bureau and the California statewide databases. This allowed for a September 7th, deadline for the public input on the Communities of Interest (COI) component of the effort.

"The submissions and enquiries about the COI have been relatively flat, but we believe the public will become more engaged once map alternatives have been created and made available for comment in discussion," said El Dorado County Board of Supervisors Chair John Hidahl.

The County GIS department is working to finalize the system to create map alternatives and a public download application which will allow the public the ability to create their own maps. The comment application will include both public and county proposed alternatives. This information was available for download beginning on September 7th,

from the County's redistricting web page.

Residents may use the download and census data with whatever tools they may have available.

GIS and the Redistricting team, as well as any maps submitted by the public, at the next redistricting public meeting which is scheduled for October 14th.

Pioneer Energy Coming to El Dorado County

Pioneer Community Energy, who will be serving El Dorado County's 68,000 western slope PG&E accounts and Placerville beginning January 2022, made a presentation to the September 13 El Dorado Hills Community Council Meeting (video here). The next day Pioneer Community Energy held the first independent Community meeting on September 14th in person at the Gilmore Senior Center and via Zoom.

As previously mentioned in the June 2021, Bulletin, Pioneer is a communityowned, not-for-profit agency which serves unincorporated Placer, and the incorporated areas of Auburn, Colfax, Lincoln, Loomis, and Rocklin.

Currently they serve 93,300 residential and commercial accounts. They were formed to provide electric generation at stable rates and to offer programs that deliver both economic and workforce benefits for the local community.

According to their web site, they are governed by a board of locally elected officials and have an established goal of providing electricity at more stable and competitive rates. Their board meetings are open to the public and the public may comment on the board's agenda items as well as on items not on the agenda generally.

They do not use taxpayer dollars and invest in local communities providing stable and competitive rates, investing in local electric projects which support and create local jobs, and expanding the energy saving programs.
